AMA Chapter No. 707

Proposed revision to the club bylaws

ARTICLES IV - DUES

- 4.1 Club dues shall be paid at a rate established by the general membership. The rate as approved by the general membership may include late payment fees or dues increases.
- 4.2 New members shall pay an initiation fee; which shall be established by the general membership.
- 4.3 Dues shall not be refundable.
- 4.4 Junior members (18 and under) shall pay ~~one-half the regular fees.~~ such dues as approved by the general membership.
- 4.5 All new members, upon payment of dues, shall be entered on the membership roster and shall be presented with a membership card, name tag, and a copy of these Bylaws.
- 4.6 Members in arrears shall be ~~automatically dropped from the active roster after six months, unless otherwise directed by a vote of the membership.~~ assessed such penalties and be suspended from the club roster and club activities in accordance with a plan approved by the general membership.
- 4.7 ~~To be reinstated to active status, prior members shall pay all dues in arrears (maximum one year).~~ Reinstatement of prior members to active status shall be in accordance with a plan approved by the general membership.

Motion to be presented to the general membership for approval

Skyknights dues structure shall be as follows:

1. Annual dues of \$65 shall be paid by April 30 of each year.
2. A late fee of \$10 will be assessed for late payment of dues between May 1 and July 30,.
3. If dues are not paid by August 1 the member shall be dropped from the roster.
4. Gate lock combinations and other similar items shall be changed each May 15.
5. Junior members are not assessed dues.
6. New members, excepting new junior members, will pay dues of \$65 prior to commencing their second training session.
7. Returning members, anyone not on the current roster, must pay \$65 dues and must repeat flight training to demonstrate safe flying capability.
